

DECLARATION FOR A HAWAII STAR VISITOR SANCTUARY

In recognition that on March 13, 1999, the Kanaka Maoli (aka Native Hawaiian/Hawaiian) people reinstated the provisional offices of the former government of the Kingdom of Hawaii. This action was implemented in accordance to international law principals and protocols and Hawaiian Kingdom laws. On November 6, 1999, a island wide election (plebiscite) was conducted to elect individuals to serve in the Hawaiian Kingdom Legislature that consists of 24 seats in the House of Nobles and 24 seats in the House of Representatives. These elected officials were no longer self proclaimed, but elected to office.

Recognizing that these newly elected officials immediately called for a constitutional convention to exercise their authority to create and establish laws. On March 29, 2000, the amended Constitution of Hawaii 2000 was enacted. Since then our government has legislated laws to reestablish the proper departments to serve as the proper authority for this nation and to assist the government operations and functions of the lawful Hawaiian Government.

In recognition that on August 31, 2003, the reinstated Hawaiian Kingdom publicly published its formal *Notice of Initiating the Transition of Political Authority and Jurisdiction from the United States*.

Recognizing that the existing State of Hawaii law - Act 195 - signed by Governor Abercrombie in July, 2011, that states "The Native Hawaiian people are hereby recognized as the only indigenous, aboriginal, (Kanaka) maoli people of Hawaii." This State law acknowledges the United Nations Declaration of the Rights of Indigenous People, particularly Article 3: "Indigenous peoples have the right to self-determination. By virtue of that right they freely determine their political status and freely pursue their economic, social and cultural development."


In recognition that on May 16, 1854, His Majesty King Kamehameha III formally proclaimed the Hawaiian Kingdom as a Neutral State which formally participated in the development of the international law of neutrality that was negotiated among the Family of Nations.


Recognizing that Hawaiian tradition recognizes Na Huihui o Makali'i (the constellation of Pleiades/Seven Sisters) as the place from which, according to legend, the first Hawaiian people came to Earth.

In recognition that newly created lava flow land at Kalapana, Kaimu on Moku o Keawe, falls under the sovereignty and jurisdiction of the lawful Hawaii Government, we the undersigned representatives do solemnly declare the creation of a Hawaii Star Visitor (benevolent extraterrestrial life form) Sanctuary where:


1. Star Visitors are invited to fly over and land at a location to be designated and consecrated as the Hawaii Star Visitor Sanctuary;

4. Star Visitor technologies can be safely demonstrated, understood and developed for the benefit of all humanity, marine and animal life, and planet Earth.


Authorized Representatives of the lawful Hawaiian Government, May 28, 2014 on Moku o Keawe.
